Student Disciplinary Issues

Disruptive Behavior – student is acting in a manner which interferes with the instructional, service or administrative functions of the college.

Examples of disruptive behavior:

- Aggressive or threatening body language or speech
- Verbal or physical altercations
- Possession/use of alcohol or controlled substances
- Theft of college or personal property
- Smoking or vaping on campus
- Behavior may be of a lesser nature such as excessive cell phone usage in class and can be handled within your division.

Procedures for handling serious situations involving disruptive behavior*

Inside the Classroom

- Stay calm. Assess severity of situation.
- Try to calm the student.
- If unsuccessful, dial Campus Safety at x27777 or 714-992-7777. **Give your location.**

- Immediately notify division dean. File an Incident Report.
- Remember, less serious/threatening incidents are handled in the division. Confer with your division dean.

Outside the Classroom

- Assess severity of the situation.
- Options
 1. Contact Campus Safety
 2. Use judgment to determine if 911 is needed (if used, dial 911 by cell or from campus phones, dial 9-911 and **give your location**). Follow with call to Campus Safety
 3. Inform your division dean.
 4. Contact a BFT member (numbers are on back).
- Always file an incident report.

Students In Crisis Situations

Immediately call 911 by cell - or on campus phones, dial 9-911. **Give your location.** Follow with call to Campus Safety.

When

- A student is a danger to self or others
- There is a visible weapon
- There is a medical emergency

Examples of “danger to self or others”

- Suicidal behavior
- Perceived imminent danger
- Student has shared suicidal thoughts or behavior in written or verbal format (emails, essays, drawings, verbal communication)
- Visible weapon is present

Examples of Medical Emergencies

- Severe chest pain
- Serious uncontrolled bleeding
- Non-responsive/unconscious
- Not breathing

Medical emergencies should be handled as if you were responding to the need of a family member or very close friend. Common sense prevails.

Incident reports must be filed with Campus Safety in all situations. **

Other crisis situations may involve students who are experiencing mental or emotional distress and may be referred to your division dean for further assistance or directions.

Title IX- Sexual Misconduct

Conduct that is unacceptable in terms of sexual behavior is a violation under Title IX. Examples include the following:

- Sexual harassment
- Stalking
- Sexual misconduct through social media
- Lewd, indecent or obscene behavior
- Rape, incest
- Dating violence and/or domestic violence
- Sexual battery or sexual assault

Sexual misconduct can occur between

- Males
- Females
- Males and females
- Third party (campus visitors/vendors) and students
- Faculty/staff and students

Campus Title IX Officer is the VPSS.



Health Services is a campus resource for students in crisis. Students who admit to being suicidal or homicidal should be escorted to the Health Services Center for further assessment. Never leave the student alone. If Health Services is not available, contact CAT (Centralized Assessment Team) at 866-830-6011.

Steps to follow if sexual misconduct is reported or observed on or off campus:

- Listen without judgment.
- Try to calm the student and assure him/her of their right to confidentiality.
- If a student indicates that he/she is a victim of rape, never leave the student alone.
- Immediately report the incident to Campus Safety who will contact the Fullerton Police Department (FDP).
- If the victim does not want to report the incident to the FPD, escort the person to Health Services.

Incidents of sexual misconduct between employees or where the student makes a claim against a District employee (faculty/staff) are handled directly by District HR.
